- a. Hope's Music Team leads our singing.
- b. **William Koopmans** welcomes us and using Exodus 30:22-38, 2 Corinthians 2:14-16, and 1 Peter 2:5 & 9, speaks to us about the Fragrance of God in Jesus Christ, who by His Spirit infuses us with the fragrance of Christ. On the addendum for today's agenda is the Credentials Advisory Team's recommendation to Classis regarding a request from one of our churches that Classis pause the practice of standing to express affirmation to the Covenant for Officebearers (CFO), with a second request that we set aside time at a future Classis to discuss this and related matters coming out of Synod 2024.

Before this request was received, the Classis Interim Committee (CIC), published a statement with the agenda indicating that we will maintain status quo regarding the practice of standing (as decided by Classis May 18, 2022 item 7.3).

So that Classis can discuss and decide any matter on the agenda, it needs to be constituted. Therefore, following the statement from the CIC, and with the knowledge and agreement from the church submitting the request, I'll be asking delegates to stand for this time. Classis will then be able to discuss and decide on the matters presented by the Credentials Advisory Team.

#### 9. Classis Church Counsellor Reports:

- a. Maranatha CRC, York Elder delegate; we have a bright future. We've just hired a fantastic youth director, Cody Miedema
- b. Calvary CRC, Flamborough Chair encourages the council to seek a church counsellor
- c. **Discussion follows about vacancies**, the load on pulpit supply (a third of the churches in Classis Hamilton are without pastors), and how long it takes churches without pastors to have their call accepted by a minister. We are reminded that lately it's been observed in the denomination that it takes between 3 and 5 years for churches to receive a new pastor.

#### 10. ThereforeGo Ministries

**Rick Zomer** (Executive Director)

(Therefore Go Ministries works with churches across Canada and the United States to offer **SERVE**, a week-long church-based mission experience for high school students).

- a. The ministry under various names has been around since 1919. Their name has changed but the mission has not. To help churches lead their youth to commit their lives to Christ and to transform this world for him.
- b. The challenges facing youth changes over the years, not easier, but different. So also the society and culture of youth changes.
- c. It's observed that fewer and fewer grads from highschool remain connected with the church
  - i. Why? One possible reason SERVE might be the only week in the year that a young person spends significant time with and adult who isn't their parent or youth pastor. If that's true what does that communicate to the young person? It's the perception of many youth, they say, the only people who spend time with me are those who have to, like parents, or people who are paid to, like my youth leader.
  - ii. SERVE gives a wonderful opportunity to change that narrative.

- 11. **Bridge App:** Is currently being used by 135 CRC in Canada. Classis Hamilton is consistently one of highest users of the app in Canada with1,812 members in Classis Hamilton. This year the app is processing 14,000 donations, roughly \$3,000,000 being processed, that's about 1/4 of what's being processed across the Canada. The average transaction is roughly \$200, showing how much the members appreciate using the app and see, for instance, second offerings listed for the month.

- (a) **Abby introduces herself**. Abby grew up in Waterdown, Bethel CRC, thought of teaching, heard about Act 5, started there in 2020, still works there part time. Saw that the campus chaplain opportunity as an open door for her as a gift from God.
- (b) **Been in the role for 2 months**; been going really well. Hired two weeks before school started, so hit the ground running. Thankful for Michael Fallon's support as well as others. Meet with students weekly, dinner, games, faith talks into their work and lives. Students from different backgrounds, churched and unchurched. Some have "no idea what I believe, I'm figuring it out, is that OK?"
- (c) **Cast a vision for us.** For Campus ministry and Mohawk College, that there is a vibrant body of students and staff rooted in Christ living out their faith in the every day. That we become known by more at the school, and even in the city.
- (d) **How can we as church of Classis Hamilton help you?** Mostly prayer, that I can see what's going on, what God's doing in the school, and in the students that we are a welcoming group. Would like to visit the churches to tell what we're doing at Mohawk. We need some people who can cook.

#### 21. COD and CMB Reports (oral report)

William Koopmans

- a. Council of Delegates (COD) and Canadian Ministry Board (CMB) met 3 days last week
- b. 10 years ago, in the CRCNA, was 14% non-white today 25% non-white membership
- c. Gathering is an exciting experience of gathering. We are invited to a group of Classes Gathering in March 2025, involving 15 reps each from Classis Rockie Mountain, Hamilton, Yellow Stone, Minkota and Grandville.
- d. Moses Chung, Pabla Kim Sun Chris Schoon have moved on each for his own reasons.
- e. Joel Vanderwerken appointed as Director of Ecclesiastical Governance (replaces Synodical Services). Al postma moves from transitional to permanent Canadian Executive Director.
- f. Sale of denominational building is final and new to us building on East Beltline much smaller from 130,000 sq ft to 25,000 sq ft will move in in December
- g. Survey in the CRCNA, see William for details
- h. Jamie McIntosh director of World Renew Canada, Bold Hope, Unrelenting Love.
- i. Financial update, change and uncertainty. More of a pinch in USA than in Canada. Six churches have indicated they are disaffiliation (there may be more). This will impact on giving; we'll see in 16-18 months.
- j. Zack King says we're at the maximum number of task forces.
- k. Canada Ministry Board (CMB) reported on joint ministry agreements and joint ministry management Committee (does the Canadian voice overwhelmed? The joint ministry management committee is equally staffed. Those agreement ensure that we on the Canadian side are in full compliance to Canadian Revenue Agency, and they help us prioritize Canadian Ministries.
- I. Terry Veldboom says (about financial stuff), "we have enjoyed a long season of excellent support and pray that that will continue into the future despite the hiccups of the last few years." Hiccups, yes, some ministries have had to dip into reserves, we've had to make some cutbacks in staff and ministry programs, and yet the church holds on to the vibrant ministries we have in Canada and has responded in a generous and committed way.
- m. Canada Ministry Board wrote a letter of response to the communication of *Toward CRC Canada* sent to the church councils. They are not an official CRC organization.

- n. Took note of an overture passed by Classis Quinte to work with the CMB (based on CO Art 44a) to hold a Canada wide conversation regarding our bi-national unity and oppoprtunities for ministry together. Staff will explore how that can unfold in a productive way.
- o. William indicates his retirement is pending.
- p. Some guestions are asked and answered.

#### 22. Credentials Advisory Team Report

Mark Verbruggen reports

- a. Regarding the Request from Meadowlands, (to pause standing and have a discussion)
  - i. Observations:
    - (1) At this first meeting post Synod 2024, every church's delegates ought to be seated with dignity and respect. We have time to sort this out, we can work together on this as we have been doing. We have an opportunity together to embody grace and truth. Other classes are reportedly having a much more difficult time than we are trying to get along. And if we really try to embody grace and truth we'll do something in Classis Hamilton that may be a model to other classes in our.
    - (2) Synod has made its decisions, and I'm happy with those decisions regarding the nature of marriage as one man and one woman.
    - (3) Yet, now is not the time to carry a big stick, but it is time to listen to one another, treat one another with respect and dignity. We have time to sort this out.
  - ii. **Recommendation:** our first recommendation has already been dealt with by the CIC and Meadowlands and we all stood. But what about going forward? So we'll look to the head table for direction.
  - iii. **Chair**: Yes, CIC is willing to dig into this, and has already thought about having a conversation in the February meeting, with an outside facilitator, but to be effective ...
    - (1) Lets take 10 minutes to hear what's on the minds of the Delegates and points they like to be part of the winter meeting conversation.
    - (2) **Chair Rules** that the stated clerk will take notes of all suggestions from the floor, to guide our conversation in February.
      - (a) **William Koopmans** thanks the CIC for links from Zack, Al, Thrive, let's not lose that help and guidance.
      - (b) Stated clerk suggests that the main concern right now is that Classis can have an informed and fruitful discussion in February. That we'll ask an outside of Classis facilitator come in to help us. Sean Baker from Thrive can do this well. He has been contacted, he is available and he says he does a lot of his consulting work in the denomination. He is willing to help us in this discussion.
      - (c) **Ken Benjamins** reminds us that an appropriate overture one way or the other would be helpful. His thinking is that we maintain the status quo until there is an overture to do something different.
      - (d) **Joel**: it might be good to determine here what we'll do at the next meeting regarding the standing or not.
      - (e) **Gina** reminds us that CIC can't tell Classis what to do.
  - iv. Chair rules we'll do at the constituting of the next meeting what we did at this meeting, and further offers advice that:
    - (1) any churches offering a suggestion as to how that might change as we seek to live into what synod has said, to offer that by way of overture to the next meeting. And,

- (2) out of our facilitated conversation we can hopefully get to resolution on whatever matters the churches may bring regarding this.
- (3) After consulting with the stated clerk, the **chair** says **that it might be best if we wait** with the overtures until we've had our guided discussion in our February meeting, and that churches take the results of that discussion for any overture to the following meeting.
- (4) **Hayden**, wants to ensure that the discussion will get to the bottom of differing issues
- (5) **Meadowlands** says part of the confusion is that the CFO mentions we might have difficulties with the confessions, but what does that mean? What is a settled conviction? All those questions should be on the table.
- (6) Chair says, please communicate with the Stated Clerk anything you think ought to be part of this February conversation.

#### b. Advisory Team Report Continues:

- i. **Ebenezer and Dundas**, raise points regarding the toward CRC Canada movement.
  - (1) Recommendation: that Classis receive both communications for information; RULED RFI
  - (2) **Recommendation:** That delegates who are concerned by, or in support of, the Towards CRC Canada group and who wish to discuss it at the Classis level submit an overture to the stated clerk. **RULED**
- ii. First Hamilton CRC requests that 9 of their officebearers, be allowed to administer Lord's Supper during the time of their pastor's sabbatical as per CO Art 55
  - (1) **Recommendation**, that Classis approve these elders be allowed to administer the Lord's Supper during the sabbatical of their pastor. **ADOPTED**
  - (2) Joel raises concern that the original request didn't mention the sabbatical, it's all late, and we were caught off guard.
- c. Chair reminds us that **getting the credentials filed on time** is a **lovely thing** saving much trouble.
